Bids received in excess of the ABC shall be automatically rejected at bid opening. Delivery of the Goods is required within **thirty (30) calendar days** from the date of receipt of the Notice to Proceed. **Bidders must have completed, within the last five (5) years** prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

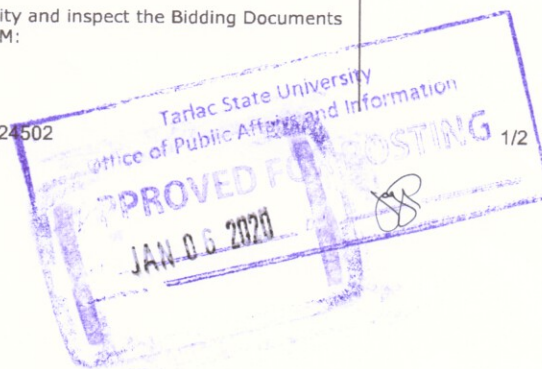
