**WHEREAS**, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Laboratory Chemicals and Reagents (APP 2023), Rebid with an Approved Budget for the Contract (ABC) of ₱ 1,725,999.55 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on January 18, 2024;


